# Proposals to apply existing lead and cadmium exemptions to new RoHS Directive

The Directive on the restriction of the use of certain hazardous substances in electrical and electronic equipment ("RoHS") has recently been revised. Exemptions to restrictions for lead and cadmium were agreed upon last year, which means they were not included in the revised RoHS Directive. These exemptions apply to (1) lead used in some ceramic materials inside capacitors, and (2) cadmium in photoresistors for analogue optocouplers in audio equipment. The Commission now proposes two delegated Directives, which will continue the application of these two exemptions by adding them to the revised RoHS Directive.

# ECHA publishes list of 116 substances to be evaluated

On 23 October, the European Chemicals Agency ("ECHA") published a draft list of 116 substances to be evaluated for health and environmental risks under REACH. The substances have been assigned to Member States, which will be responsible for evaluating them between 2013 and 2015. The list is known as the Community Rolling Action Plan, or CoRAP. It represents an expansion of the 2012 – 2014 CoRAP, which listed 90 substances for evaluation.

# Commission publishes emission caps for non-ETS sectors

On 18 October, the European Commission published the annual emission allocation limits for sectors not covered by the Emissions Trading Scheme ("ETS"). The draft Commission Decision lays down the greenhouse gas emission limits in tonnes to which each Member State must adhere for each year between 2013 and 2020. The European Parliament and the Council now have three months to review the text of the Decision. If they do not raise any objections, the

# New eco-design requirements for domestic tumble dryers

On 3 October, the Commission adopted a Regulation establishing eco-design requirements for household tumble dryers. All household tumble dryers must comply with these requirements before being placed on the market in the EU. The requirements do not apply to household combined washer-dryers. Although the Regulation applies from 1 November 2013, the generic eco-design requirements only apply from 1 November 2014 and the specific requirements from 1 November 2015.

# Commission issues report on nuclear safety in the EU

On 4 October, the European Commission issued a Communication on the comprehensive risk and safety assessments ("stress tests") of nuclear power plants in the EU. The report suggests technical upgrade measures to improve safety, suggesting that most of the 132 nuclear reactors in operation in the EU should be upgraded by 2015. The Commission is expected to submit a proposal early next year to revise the Nuclear Safety Directive, in order to take the results of the stress tests into account.

# Energy Efficiency Directive gains final approval

The Energy Efficiency Directive has received a final rubber-stamp from the Member States, signalling completion of the EU legislative process. The Directive already received overwhelming support from the European Parliament on 11 September (632 in favour, 19 abstentions, 25 against). The Directive establishes common measures for the promotion of energy efficiency in the EU, to help the EU achieve its 20% energy efficiency target by 2020. It requires each Member State to set an indicative national energy efficiency target. By 30 June 2014, the Commission will assess the progress achieved and pronounce on whether the EU is likely to reach its 2020 goal. Following entry into force of the Directive, the Member States will have 18 months to implement most of its provisions in national law.

# Commission adopts new proposal on biofuels

On 17 October, the European Commission published a proposal for a Directive amending the legislation on renewable energy. The proposal introduces a 5% limit on biofuels and bioliquids produced from food crops. It also introduces new reporting requirements for estimated emissions from carbon stock changes

caused by indirect land-use change ("ILUC"). The proposal does not take a position on the need for financial support for biofuels before 2020.

# New tyre labelling scheme enters into force

As from 1 November 2012, a label must accompany all new tyres sold in the EU. The label can either be affixed to the tyre itself, or provided to the dealer or end user on delivery. The label must contain information on their fuel efficiency and other parameters, including wet grip performance and rolling noise. The labelling requirement has been applied on a voluntary basis from 30 May and will now become mandatory. Certain categories of tyres remain exempt.

# Commission announces 2013 work programme

On 23 October, the European Commission adopted its 2013 work programme. In the environmental field, the Commission noted that "the EU needs a long-term framework for energy and climate policies so that investment and policy target competitiveness and tackle climate change". In light of this, it announced that it will be working on a new climate and energy package for the period up to 2030. The package will be comprised of both legislative and non-legislative measures, and has three stated objectives:

- To meet an 80-95% GHG emission reduction objective in 2050 compared to 1990:
- To foster long-term competitiveness, security of supply and sustainability; and
- To provide a long-term perspective for investments until 2030.
