- Leadership abilities

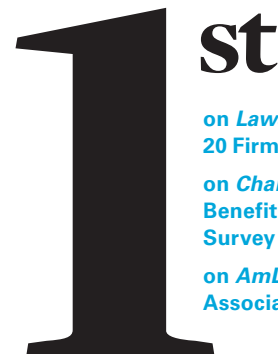
### How to apply
