- iv. In Peru, prior to 2021, only transactions in the fields of electricity generation, transmission or distribution were covered by Peru's mandatory pre-notification requirements. In 2021, new legislation was passed applying Peru's merger control requirements to all industries.
- v. "NR" indicates the jurisdiction released an annual report to the OECD that did not report the number of merger notifications.
- vi. "N/A" indicates the jurisdiction has not published an annual report regarding merger notifications for that year.
- vii. Australia notifications are total number of transactions notified in FY ending 30 June of each year.
