Overview

Every large law firm is structured slightly differently and has its own areas of expertise. At White & Case, our lawyers are structured into regional sections, with some sections composed of different practice areas. This guide provides a brief introduction into those sections and groups. At the end of the guide, you will find a summary of which practice areas are available in which US offices.

While we ask our summer associate candidates to provide their practice area preferences during the interview process and prior to the start of the summer, all of our summer associates have the opportunity to try work in various areas. At the end of the summer, they are asked to rank their practice area preferences. Once they receive a full-time offer, the Firm then communicates in which practice area they will be placed as a first-year associate.

In most of our US offices, our first-year associates are placed directly into a practice area. In Houston and New York, first-year

associates are part of either a Corporate or Litigation Pool with two focus areas (called a major and a minor) in which they receive the majority of their assignments. Interests, business needs and feedback during the summer are all taken into account when making practice area placement decisions. Those in a Pool for their first year will be placed into either their major or minor around May of the following year.
