European Chemicals Agency consults on 54 proposals for Substances of Very High Concern

On 3 September, the European Agency opened a consultation on 54 chemicals that could be classified as substances of very high concern (SVHCs) on the REACH candidate list by the end of the year. The list of substances includes acetic acid, 21 lead compounds, the flame retardant deca-BDE, a series of perfluorinated acids, the phthalates n-pentyl-isopentylphthalate and diisopentylphthalate, and several azo dyes. Substances on the candidate list are subject to extra information requirements. They will also be considered for addition to the REACH authorisation list.

The public consultation will end on 18 October 2012. Interested parties can post their comments on the ECHA website.

# Commission extends deadline for approval of triclosan

On 20 August, the European Commission adopted a decision extending the deadline for companies seeking EU approval for use of the biocide triclosan in disinfectants and as a preservative. The extension also applies to 2-phenoxyethanol. The new deadline for the submission of dossiers is 30 September 2013.

On 11 July, the Commission issued a Regulation amending the eco-design requirements for glandless standalone circulators and glandless circulators integrated in products. The Commission believes the amendment is required in order to avoid unintended effects on circulator markets and on the performance of the products covered by the Regulation.

# New draft eco-design rules for lighting

In July, Member state experts supported new eco-design standards for directional lamps, LED lamps and related equipment. The proposal introduces increasingly stringent energy efficiency standards in 2013, 2014 and 2016. The proposal has now passed to the Council of Ministers and the European Parliament, which have three months to raise objections.

# EU regulatory committee approves end-of-waste criteria for glass

In July, an EU regulatory committee has approved end-of-waste criteria for glass cullet. The European Parliament will now scrutinise the end-of-waste rules before they are adopted by the European Commission, which is likely to happen in the coming months. The Committee failed to reach agreement on criteria for scrap copper and recovered paper.

#### New WEEE Directive enters into force

On 24 July, the revised Directive on waste electrical and electronic equipment ("WEEE") was published in the EU's official journal. The revised Directive will apply to specific types of WEEE from 13 August 2012 to 14 August 2018. After that, all forms of WEEE will be covered, with certain exemptions. The new directive is broader in scope than the previous directive, and applies stricter national collection targets.
