## CHEMICALS

### Council and Parliament agree on new EU biocides rules

On 17 November, during a third trilogue meeting, the European Parliament and the Council reached a provisional agreement on the new EU biocide approval Regulation. The new Regulation is set to replace the existing 1998 Directive. It covers pest control products such as rat poisons and insect repellants, but not agricultural pesticides. If it enters into force, the new Regulation will allow different procedures for authorising biocidal products on the market and will set 'cut-off' criteria, banning a number of dangerous chemicals. The provisional agreement must now be officially approved by both the European Parliament and Council. The Parliament is expected to vote on the Regulation in its plenary session in January.

### Provisional agreement reached on detergents

On 15 November, the European Parliament and the Council reached a provisional agreement on the ban on phosphates in domestic laundry detergents and in dishwasher detergents. The Parliament is expected to formally approve the agreement in its plenary session in December.

## CLIMATE CHANGE

### UN climate change meeting in Durban

On 28 November, the UN's climate change talks commenced in Durban, South Africa. The aim of the talks is to determine the future of the protocol, and to create a legal framework for reducing greenhouse gas emissions. Durban is the final chance to extend efforts under the Kyoto protocol, before the first commitment period expires in 2012. The EU has expressed its willingness to sign up to a second commitment period. However, chances of agreement are slim, since the US, Japan, Russia and Canada have all said they will not re-commit unless countries such as India and China also sign up. On 6 December, the UN chief Ban Ki-moon said that a globally binding climate deal looks increasingly unlikely to be agreed in Durban. However, a major breakthrough was reached on Thursday 6 December, when negotiators agreed on implementation of carbon credits from carbon capture and storage (CCS) projects in developing countries.

### Commission proposes to update rules on emissions monitoring

On 9 November 2011, the Commission published two new draft Regulations on monitoring, reporting and verification under the EU Emissions Trading Scheme (EU ETS). If adopted, the Regulations would change how Member States monitor and report their greenhouse gas emissions. The Regulations would come into force on 1 January 2013, to coincide with the start of Phase

## ENERGY

### Belgium begins to phase out nuclear power

On 31 October, Belgium's main political parties agreed to phase out nuclear power. The agreement confirms a decision which was first adopted in 2003, but then shelved. The plan is to close down three of the country's seven reactors by 2015, with a complete phase-out by 2025.

## GREEN PUBLIC PROCUREMENT

### Commission publishes Green Public Procurement guidance

On 14 November, the Commission published a guidance document on Green Public Procurement entitled *Buying Green! A handbook on green public procurement*. The handbook is intended to help public authorities to implement green public procurement. It explains how environmental factors can be taken into consideration at various stages of the procurement process, within the framework of the EU rules on public procurement.

## OTHER

### Commission adopts 2012 work programme

On 15 November, the European Commission adopted its work programme for 2012. According to the programme, in 2012 the Commission's DG Energy will focus on developing positions on energy technologies and efficiency. It will also put forward a proposal to harmonise the framework for nuclear power safety. DG Climate Action plans to make a proposal to revise the rules on fluorinated gas and start preparing a climate adaptation strategy. DG Environment plans to release a water "blueprint" which will review the Water Framework Directive, simplify the rules on environmental impact assessments, and propose revisions to the EU strategy on endocrine disruptors.

### European water certification system launched

On 24 November, the European Water Partnership launched a European water certification system, known as European Water Stewardship ("EWS"). The EWS aims to be a means of communication for industry and agriculture on good practices and compliance with standards. It provides guidance and defines tools for industrial water users to help them diminish any adverse environmental impact of their water use, and to achieve sustainable water management. The Environment Commissioner Janez Potocnik applauded the initiative at its inauguration this month.
